





These are some of the core questions of our day. However, they are not the most important questions. If you are a parent or a grandparent, God has given you a more essential mission than leading our nation toward godliness, and that is leading your own children and grandchildren toward godliness. If we are not careful, we can pour our greatest efforts toward changing and restoring our nation, while we lose the souls of our own children.

Repentance

This is the exact path I was on as a youth pastor. For ten years I gave the best of my heart, passion, and ministry to teens and their families in the church and the community. God blessed those efforts in many ways, but I was neglecting my family. While I was giving everything to families at church, I had absolutely no plan to pass my faith to my children at home. I was praying with friends, but not with my family. I had developed plans to teach young people God's truth in the Bible, but was not doing it at home with my own sons and daughters.

In the summer of 2003, God brought me to a deep place of repentance and turned my heart to the most important ministry and calling He has given me which is to partner with my wife and "make disciples" of our children.

The devil loves us to put second things first. He loves it when we put our jobs before our families. Our friends before our spouses. Our hobbies before our church. In the Christian world he is particularly good at getting believers to put their "ministry" ahead of the discipleship of their children.

How many Christian leaders have had "great" public ministries while their own children rebelled against both them and the Lord? How many Christian leaders have been passionate to lead our nation back to its Christian heritage but shattered their families in the process? Let these things never be said of us!

Begin at home

The first and the greatest commandment in Scripture is found in Deuteronomy 6:5. "Love the Lord your God with all your heart, and with all your soul, and with all your strength." This is the purpose of life for us and for our children. In verses 6-7 God then gives His people a specific mission and a concrete action. "Impress [the Word of God] on your children. Talk about [His Word] when you sit at home."

Springfield Update

Please take a few moments to contact your state lawmakers about the bills below. These are some of the bills which are currently on IFI's radar screen as lawmakers go back into session on January 31st.

PRO 🗸

Ultrasound Opportunity Act (HB 4085) — This bill would require abortion providers to simply offer an ultrasound picture to women considering abortion. The choice of whether or not to view the ultrasound picture is still hers. Research has proven that between 70 and 90 percent of "abortion minded" women who see images of their unborn children choose life.

Abortion Clinic Safety Regulations (HB 4117) — would require abortion clinics that perform more than 50 abortions a year to meet basic safety regulations of other similar outpatient treatment centers.

Marriage Amendment — SJRCA 16 and HJRCA 10 would permanently define marriage as the union of one man and one woman in the Illinois state constitution. The threat to natural marriage is clear and present. In January, a group of out-of-touch lawmakers met in Chicago to discuss their strategy of bringing homosexual marriage to Illinois.

"Comprehensive" Sex Ed — HB 3027 has already passed the Illinois Senate and is pending a vote in the Illinois House. This bill would <u>mandate</u> that public schools who teach sex education teach "comprehensive" sex education in grades 6-12. Illinois law currently mandates that schools teach abstinence until marriage.



Teaching "comprehensive" sex education is currently optional and a local school decision.

Gambling/Casino Expansion

— Representatives of the state's casinos, the horse racing industry and the offices of Governor Pat Quinn and Mayor Rahm Emanuel of Chicago met last month to see if they could reach an agreement on gambling expansion. We fully expect another push for casino expansion.

Medical Marijuana — HB 30 would permit out-of-state patients to smoke marijuana without police interference; would permit persons to grow and possess marijuana and operate a motor vehicle in violation of DUI laws. ★

Marriage "equality" in the Land of Lincoln?

Six months after Illinois' "civil union" legislation went into effect, forces committed to redefining natural marriage are already planning their next steps. A recent article in the *Huffington Post*



reports that a "group of Illinois lawmakers have begun laying the groundwork for their latest push to bring marriage equality to the Land of Lincoln," despite the fact that through the civil union law, same-sex couples already receive all the benefits they claimed they wanted.

This meeting included the Illinois General Assembly's three openly homosexual members: State Representatives Greg Harris (D-Chicago), Kelly Cassidy (D-Chicago), and Deborah Mell (D-Chicago). State Representatives Ann Williams (D-Chicago), Sara Feigenholtz (D-Chicago) and State Senator Heather Steans (D-Chicago) are also listed as part of the coalition to redefine marriage.

Anyone paying attention should have expected this because homosexual activists have explicitly stated that civil unions are merely a stepping stone to their real goal: the eradication of marriage as it's been understood throughout history.

It's not benefits they seek; it's the societal approval that accompanies legal recognition of homosexual unions as "marriage." Of course, homosexual unions will never in reality constitute marriages, but like the proverbial emperor who had no clothes, when the government acts like they are marriages, society will play along with the foolish game of pretend.

Contact your state lawmakers today and ask them to uphold natural marriage and to support a state constitutional amendment to permanently define this foundational institution. We can stop this destructive policy from moving forward, but we must take up the fight again, and be willing to make our voices heard. *
