



## from the Executive Director — David E. Smith



In 1936, Beman and Polly Crandall were forced by their pioneer circumstances to make do with the canvas roof of their covered wagon for months after their mid-winter arrival in the yet-to-be-settled town. Their frigid 1500 mile journey from Connecticut over the rock hard wagon trails of northeastern America prepared them for the difficult mid-western struggles that lay ahead.

In addition to homeschooling their ten children, Beman was the first postmaster, one of the first school directors, one of the first election judges, and the first justice of the peace in what is now called Crystal Lake.

At our recent East Peoria dinner, Michael Medved joined me in listing the challenges that face us in Illinois and our nation. Whether I was outlining the fierce push for gambling expansion, the horrific advance of the death culture, or the government's tragic embrace of the homosexual political agenda, the chiseled and steady faces of the audience bespoke the determination that Christian grit, courage and love will overcome these evils.

Michael Medved focused his remarks on the question of whether "social issues" are important. He declared that issues like fatherlessness and abortion are intertwined with economic concerns.

Fifty-three million people are missing from the American workforce today because they were killed since *Roe vs. Wade* awarded women the legal right to abortion in all fifty states. A baby born during the first year of this controversial decision would now, at the age of 38, be in the prime years of his/her working life.

Medved also revealed that when Social Security was created in 1937, there were 18 working Americans for every person who collected the taxpayer-funded retirement check. Presently there are less than three workers for every person collecting Social Security. Clearly, the damaging consequences of abortion extend far beyond the murderous act itself.

Homeschooling is as relevant today as it was in the Crandall's day. In a video produced by the Illinois Family Institute, Dr. Erwin Lutzer of Moody Church makes a chilling observation. In 1938 Hitler banned homeschooling, believing that while the body may belong to the family the "soul belongs to the Reich." What the Crandalls practiced out of necessity, many still do today—necessity to safeguard their children from the anti-Christian

# "Civil Unions" Vs. Adoption Agencies

**Illinois State Senator** David Koehler (D-Peoria) and Bill Haine (D-Alton) introduced SB 1123, a bill to allow religious organizations to refuse adoption or foster care privileges for homosexual partners joined by "civil unions."



In other words, this bill would allow Catholic Charities, Lutheran Child & Family Services and Evangelical Child & Family Services to operate by the dictates of their faith. SB 1123 failed in committee by a vote of 7 to 6. Equality Illinois, the ACLU and the

Log Cabin Republicans worked to oppose this bill.

"This legislation allows Catholic Charities to operate within Church teachings, within the law, and always with the best interest of the child at the forefront," said Robert Gilligan, Executive Director, Catholic Conference of Illinois. "Our agencies serve thousands of abused and neglected children in Illinois and are constantly rated a top performer by the Department of Children and Family Services (DCFS) in providing permanency, stable foster homes and protection from further harm. We simply want to

Catholic Charities accepts adoption and foster care applications from legally married couples and non-cohabiting single individuals. However, if a request is received from an individual in a cohabiting relationship (regardless of sexual orientation), out of respect for church teaching, the agency refers them to the DCFS or another licensed child welfare agency in the community.

Obviously, the ideal way to handle this travesty is to repeal both the "civil unions" and "sexual orientation/gender identification" laws. And we hope to work toward that solution in the future. Unfortunately, the political reality of Springfield makes that impossible at this time. So in the effort to peal back the harmful effects of the "civil unions" and "sexual orientation" laws, IFI is working in support of this legislation in an effort to mitigate the assaults on religious liberty.

SB 1123 respects the long-standing and effective public/private partnership between DCFS and faith-based organizations in providing child welfare services. In addition, the legislation ensures that the current casework, therapeutic relationships, and support systems for thousands of abused and vulnerable children and families served by faith-based agencies are not disrupted.

## Passing the Baton — **Essentials for Dads**

A continuing series of articles by Grady Hauser, author of Passing the Baton — 100 Life Principles and Skills Every Father Needs to Teach His Children.

#### 1. Telling the Truth— It's No Accident

My day job is in the printing industry. We have a saying that goes like this: "If you admit your mistake when the job is in film, it will cost you \$100. Keep your secret until the job is on press and it will cost you \$1,000. But hold your secret til the job is in the mail, and it will cost you \$1,000,000." You could probably agree with this based on your own experience, dad, when you told the truth early, or perhaps you didn't have the courage to tell the truth until later, and the costs were immense. Obvious examples, such as Bernard Madoff, come to mind, but it's not just the famous cases where this holds true. Ours and our children's reputations, jobs, and family leadership can be lost if we fail on this most basic virtue. And unless this principle is learned early during childhood, it is almost impossible to learn in adulthood. Just ask the Madoff family.

Against this negative, it is important to point out a positive. If you or your children do come clean early, and admit your failure before you are found out, self confidence and respect from others is actually gained and real damage is minimized.

Dad, give your kids the invaluable treasure of teaching this principle. Firmly discipline the transgressions and absolutely celebrate the victories where the painful truth is told early.

#### 2. The 18-year-old ceremony

During an entire childhood we have the opportunity to build a few very special events—so special that they can create shared memories and help anchor the predicted storms of adolescence and the smoother waters of early adulthood. We had six of these events (see p.78 www. baton100.com), but I'll share one of my

Following their 18th birthday, both you


and your child will see the finish line coming soon—where they leave home in some form. You will have invested days. years, some tears and gained a few gray hairs at this point. Your child will know much of your heart and of life's principles

In order to honor and distinguish this moment, plan a special dinner in a private room at a favorite restaurant. It is important that you invite about 6 key individuals for this; people who have had a strong influence in the spiritual and emotional development of your child. This may be a grandparent, a coach, a music instructor, a youth group leader, etc. These people may not all know each other, but they have all been a critical part of the process. At the end of the meal have the individuals take a few minutes to personally share with your son/daughter and offer a challenge to follow their example: to resolve to walk with God as they grow up. And you, of course, are the last in the circle to share your heart. Following all of the sharing, your son/ daughter will want to respond briefly in kind to the group.

Include your teen in the planning of the dinner and be sure to dignify the event by dressing up and taking pictures. Trust me; this is a lifetime event everyone will remember. ■






# Capitol Commission

"Homosexuality and abortion must be condemned. To fail to condemn evil is to condone it." The ministry of Capitol Commission operates in 17 out of 50 state capitols.

**Shaun Lewis** is Capitol Commission's Director in Springfield, Illinois. The youthful seminary graduate and father of three talked with me by phone recently.

"Homosexuality and abortion must be condemned," he said. "To fail to condemn evil is to condone it." It was refreshing to hear the Masters Seminary graduate speak so candidly about these difficult subjects. He told me that while he doesn't get directly involved in "specific legislation" he does see a need to stand for truth. Shaun acknowledged that he "sees great value in what [IFI] is doing."

World magazine quoted (now former) Illinois lawmaker Paul Froehlich regarding the Capitol Commission ministry in 2008, "We shouldn't just fall back on that old comfortable individualism, 'Well, we'll just talk to people one on one.' I'm afraid that's not the way you really change society. You've got to change the law to be able to achieve greater justice."

Lewis, the author of a weekly printed Bible study that he hand delivers to politicians and their staff each week, spoke warmly of Froehlich. Shaun said that politics is like pulling weeds but missing the roots. He sees his approach as an essential partner in pulling up the whole corrupting nettle, root and all.

"You've got to change the law to be able to achieve greater justice."

"If all we do is attack politics, we're not at a deep enough level," he said. Referencing prohibition and

William Wilberforce, the famous British parliamentarian credited with ending slavery in England, Lewis observed that people and the culture must change in addition to law. He views the work of the Capitol Commission as a partner in bringing about that kind of deep

Featured prominently on the Capitol Commission website are ten two-page Bible studies. These are the same studies that Shaun Lewis hand delivers to politicians and their staff members each week. Each study is based on verses in the Bible.

On April 28th, he offered one entitled "Comfort in Crisis" based on Psalm 77. He begins this study appropriately telling the story of Horatio Spafford, the Chicago lawyer who lost all four of his young daughters in a tragic shipwreck after the Great Chicago Fire of 1871, in which Spafford lost a fortune. His wife and daughters were on the ship seeking respite from the consequences of the Great Fire. This overwhelming tragedy inspired Spafford to pen a most famous hymn on the ship as he crossed the Atlantic to join his wife.

When peace, like a river, attendeth my way, When sorrows like sea billows roll; Whatever my lot, Thou has taught me to say, It is well, it is well with my soul.

It is comforting to know that the gospel of Jesus Christ is going forth in a thoughtful and compelling way in State Capitols all across America. Thank you Shaun Lewis for your Christian commitment to the people who work in the State House in Springfield.

As we ended our phone conversation he said, "The issue is to bring it back to Scripture. There is an absolute right and wrong. When you disagree with the Bible, you're not offending me, you're offending God."

Amen. ■

# **Another Lesbian** Goes to Springfield

on. This bill would have eliminated all abortion restrictions in Illinois.





## To Lawmakers:

# **NO** Condoms for Children

Former U.S. Attorney for Massachusetts, Frank McNamara, Jr. had a fantastic column in the *Boston Globe* on condoms and sexual abstinence (4/20/2011). In talking about the Left's effort to make condoms even more readily available and free to children as young as 11 (the mayor of Philadelphia offers to mail condoms to teens and preteens through a website), McNamara points out the two contradictory messages being transmitted:

The first is amoral: sex in high school is tacitly okay, a recreational sport about which adults are agnostic, so long as it is 'safe.' The second is irrational: sex for high school kids is, well, not okay, but we adults trust neither you kids to abstain nor ourselves to lead.

The refrain of "safe sex" is easily translated in young minds "to invitations to have sex, as students interpret adult quiescence as a green light to experiment." Who is likely to suffer the most? The young girls who are more easily coerced and exploited for sex will suffer. McNamara also rightly points out that statutory rape laws say that sexual intercourse or sodomy with a minor is criminal, and schools that distribute condoms could easily be considered as accessories to these crimes.

A school abdicates its responsibility and squanders an important teaching moment when it transmits a blasé 'it's-okay-to-just-use-a-condom' signal, behaving as if it either doesn't know or doesn't care about the many destructive physical and psychological forces that scar kids venturing prematurely into this complex arena.

Here in Illinois, we are working hard to oppose a terrible "comprehensive" sex education bill that will require many schools to teach graphic, inappropriate sex education programs. The bill number is SB 1619.

Planned Parenthood and the ACLU are behind this bill. The ACLU claims that by teaching the traditional abstinence-until-marriage curriculum, schools "deny students crucial information they need to prevent pregnancy and protect them from sexually-transmitted diseases (STDs)."

This is absurd since abstinence will never result in pregnancy and STDs.

Yet these liberal organizations would rather use your tax dollars and public school resources to encourage young people to experiment with risky sexual behavior, such as oral sex and homosexuality.




or the music lover, John Lennon's "it" was nothing more than the birth of a new music style from the Quarrymen, who later became the Beatles. Many readers of this article know first-hand the wonder of that music. Their unique style and passion drove crowds wild and energized the youth with powerful new tools of self-expression – free love, Age of Aquarius and all that jazz.

But for conservative culture watchers, that was the day something else started 'moving'. The tectonic plates of American values were about to shift by a series of moral and cultural earthquakes that persist to this day. The "free love" of the 1960's created aftershocks that have reverberated into an epidemic of STD's, drug abuse, abortion on demand, fierce demands for marriage redefinition and a host of pathologies producing uncontrolled narcissists, ignorant of history and all its attendant perversions. And sadly, many of the original hippies and their progeny are now seated in the halls of academia, politics, courts of law and even clergy. That's the bad news.

Yet something (or Someone) else was moving in the earth. Protestants and Catholics were communicating in greater measure in prayer and worship gatherings Pope John XXIII convened the Second Vatican Council from 1962-65. While he did not live to see its completion, this seminal convention...

...was different from previous councils...
John XXIII... judged that the time was ripe
for the Church to give a new expression to its
unchanging faith — leaving behind the style that
had been shaped by the Council of Trent. ...
Sensitive to the 'rhythms of history', ... [he was]
convinced that the Church must respond to the
needs of a changing world...The Catholic world
responded with astounding enthusiasm....(1.)

Vatican II paved the way for "The Joint Declaration on the Doctrine of



Justification" (JDDJ) signed October 31, 1999. (2) This document remains significant in its scope of bridging historic Catholic/Protestant divides. Cardinal Edward Cassidy of the Vatican and German Lutheran bishop Christian Krause, meeting in Augsburg, Germany, co-signed the document.

The above two mentioned conventions, among other dialogue and gatherings both before and after, have created an environment for what is arguably one of the most important documents penned on American soil in at least 100 years. Originally signed by about 150 prominent Christian clergy, ministry leaders and scholars of various Evangelical, Catholic and Orthodox Christian traditions, The Manhattan Declaration was released at a press conference in Washington, D.C. on November 20, 2009, and warns the government:

Because we honor justice and the common good, we will not comply with any edict that purports to compel our institutions to participate in abortions, embryo-destructive research, assisted suicide and euthanasia, or any other anti-life act; nor will we bend to any rule purporting to force us to bless immoral sexual partnerships, treat them as marriages or the equivalent, or refrain from proclaiming the truth, as we know it, about morality and immorality and marriage and the family. We will fully and ungrudgingly render to Caesar what is Caesar's. But under no circumstances will we render to Caesar what is God's. (3).

So what does all this have to do with American cultural declension and our families, communities and nation today? The Scripture says, "I looked for a man among them who would build up the wall and stand before me in the gap on behalf of the land so I would not have to destroy it, but I found none." (Ezekiel 22:30) Like Nehemiah of old, we are called to rebuild the walls with God going before us. Rebuilding together is no longer optional. It is vital for the very survival of Western Civilization. And to do this, we must walk in the footsteps of the Master. (John 15:5)

So what can we do? We can 'stand in the gap' with intentional prayer together with our Christian friends, regardless of their church affiliation. We can purpose to live selflessly and in obedience to His commandments. (John 17:21)

And we can demonstrate a life of faith, hope and love toward all—both our families, neighbors and yes, our enemies. For their sake and for the glory of Christ our Lord, let us put aside our secondary doctrinal differences and offenses, letting the world see that we are Christians by our love for one another. Unflinching in our stand for truth? Absolutely! But perhaps Thomas Jefferson got it right when he said:

"In matters of style, swim with the current. In matters of principle, stand like a rock."

Will you join IFI and other organizations by 'standing in the gap' for your Nation? Together, let's rock for America.

# **Springfield Update**

Bills covering a wide range of issues were introduced in the new 97th General Assembly that began in January.

## **SUPPORT**

#### **PRO-LIFE**

HB 786, sponsored by State Representative Brandon Phelps (D-Harrisburg) creates the Ultrasound Opportunity Act. This bill requires that before a woman can obtain an abortion she be offered the opportunity to view an image of her baby through ultrasound. The decision whether to view it is

Pro-abortion legislators have slowed down its passage by filing various kinds of "notes." Judicial Notes, Correctional Notes, Land Conveyance Appraisal Notes and Housing Affordability Impact Notes, among other unrelated requests, were filed on HB 786.

Planned Parenthood is working overtime in opposition to HB 786—so much for giving women a fully informed "choice." Please ask your state representative to **support HB 786**.

**HB** 3156, sponsored by State Representative **Darlene** Senger (R-Naperville) would amend the Illinois Ambulatory Surgical Treatment Center Act. This bill would require any facility that does 50 or more abortions a year to meet the health and safety standards of other ambulatory surgical treatment centers (ASTCs).

Where are the rare, safe, and legal abortions that the "prochoice" advocates say they want?

HB 3156 failed in the House by 3 votes.

HB 2093, sponsored by State Representative David Reis (R-Olney) would amend the Illinois Abused and Neglected Child Reporting Act, requiring medical personnel and licensed counselors that provide abortions, abortion referrals or contraceptives to report any reasonable suspicion that a child may have been abused or neglected.

This bill came as a result of Virginia Planned Parenthood personnel who were exposed after repeatedly failing to report the sexual abuse of minor girls.

This bill passed the House and is now in the Senate. Please ask your state senator to support HB 2093.



## **OPPOSE**

#### **COMPREHENSIVE SEX-EDUCATION**

SB 1619, sponsored by State Senator Heather Steans (D-Chicago) requires that if a public elementary, junior high or senior high school class teaches sex education, they must "place substantial emphasis on both abstinence and contraception." This would take away the local control of school districts that choose to use abstinence-only education programs and reject graphic condom training components of the "comprehensive sex education" curricula that would be required under "contraception" and other passages in SB 1619.

SB 1619 requires that "course material and instruction shall be free from bias in accordance with the Illinois Human Rights Act." Since "sexual orientation" is in the Human Rights Act, all sex education courses would have to include examples of not only heterosexual relationships but same-sex relationships and behaviors as well.

While stating that "abstinence" must be taught, SB 1619 removes the words "until marriage" from the State's long-standing public policy and standard. Without the standard, it would become abstinence until....when? Until he says he cares? Until your second date? Removing "until marriage" is also a move to deal with the new "civil unions" law that will go into effect on June 1st, since homosexuals cannot marry.

Please call your state senator to urge him/her to oppose SB 1619.

#### "MEDICAL" MARIJUANA

HB 30, sponsored by State Representative Lou Lang (D-Skokie) creates the Compassionate Use of Medical Marijuana Pilot Program Act. This latest version would allow a "qualified" patient to have 2.5 ounces of marijuana every two weeks [enough to make 183 joints or 13 every day]. This is much more than regular marijuana users would use. What will be done with the unused joints?

The bill requires that the Dept of Public Health "give reasonable notice of an inspection or testing" to the dispensaries which will grow and harvest the marijuana. This is similar to calling a crack house the day before to announce that authorities are coming!

In other states that have legalized "medical marijuana" there are tens of thousands of card carrying "patients" approved each year. Even the sponsors of HB 30 admit that those states are a mess and the law is abused. It will be the same in Illinois. HB 30 allows



any card carrying "patient" from those states to come to "visit" Illinois and smoke marijuana without police interference.

HB 30 allows a medical marijuana patient to operate a motor vehicle 6 hours after consuming marijuana while research shows that a single joint with a moderate level of THC can impair a person's ability to drive for more than 24 hours! HB 30 totally disregards Illinois' DUI laws.

Please ask your state representative to **oppose HB 30**.

#### **GAMBLING**

SB 1297, sponsored by State Senator Antonio Munoz (D-Chicago) legalizes remote caller bingo.

SB 1297 eliminates the prize limits for bingo, allowing highstakes bingo games at multiple locations networked by audio and video technology to transmit remote calling of a live bingo game. There are not enough inspectors in the Department of Revenue to regulate the current law, and remote caller bingo would be unenforceable. The possibility of fraud is a real concern. One company could provide the administrative, managerial, technical, financial, and security personnel for all the charities. Anyone 18 and older can gamble on Bingo. Making gambling more accessible and eliminating the prize limits would attract more people and potentially create even more gambling problems.

Please ask your state senator to **oppose SB 1297**.

HB 3107, sponsored by State Representative Lou Lang (D-Skokie) will expand video slot machines to racetracks in Illinois.

Research proves that the presence of gambling within a fiftymile radius doubles the incidence of pathological gamblers. HB 3107 must be killed. This dramatic gambling expansion would transform six racetracks into land-based casinos by legalizing slot machines and video gambling. Some people think this will help the horse racing industry. It won't.

Illinois Church Action on Alcohol & Addiction Problems (ILCAAAP) points out that slot machines do not attract more people to bet on horses, "Slot machine revenue accounts for 90% or more of the revenue at racetrack casinos. When slot machines are introduced at racetracks, pari-mutuel wagering decreases significantly—20 percent to 40 percent."

Please ask your state representative to **oppose HB 3107**.

## Don't Meet ASC's Health and Safety Standards

## Honestly, it made me very

**uncomfortable.** Just a few feet in front of me, in a Capitol hearing room, sat a number of women from Planned Parenthood. Another woman from the ACLU, a lobbyist, was there to testifying before the committee against proposed abortion clinic regulations.

Down the row from me was the legislative director for the ACLU. Their mission: to keep the Illinois General Assembly from enacting sensible licensing and regulations for abortion clinics—regulations that would simply bring them up to the standards of other outpatient surgical centers. They want to stop HB 3156.

They tried to make the case that their "industry" has a fine safety record, and that horrific occurrences like the killings at the Women's Medical Services clinic in Philadelphia can be prevented with a few minor tweaks to existing regulations. That's baloney.

In spite of the tragedy at the Gosnell clinic, which attracted international attention, abortion proponents are fighting to keep business as usual. In spite of law enforcement and medical experts that say upgrading abortion clinic regulations is absolutely vital to protect women's life and health, the abortion industry will continue to pull its political strings and get away with murderliterally. *Unless....* 

Unless you, and your fellow pro-life friends, neighbors, church members, everyone takes the time to contact their Illinois State Representatives and Senators and ask them to support House Bill 3156, or any future legislation that includes requiring abortion clinics to meet the Ambulatory Surgical Centers' (ASCs) regulatory standards.



write often about homosexuality because I'm certain that there are no more serious threats to fundamental speech rights and religious liberty than the efforts to use public education, law, mainstream news media, and the arts to normalize homosexuality and gender confusion.

In addition, real people and real families are being incalculably harmed by the corrosive lies that pervade our culture. Parents' rights to oversee their children's moral education are being undermined and even stripped by the homosexualist agenda. And the temporal and eternal lives of individuals who experience same sex attraction are being destroyed.

We humans have the capacity to please the omniscient, omnipotent, eternal Creator of all creation. The failure to apprehend the meaning of that astounding idea reflects a tragic failure of imagination.

And our dear friends and loved ones who may never experience heterosexual attraction deserve to be told that a celibate life lived in submission to God is not a lonely, unfulfilled life. They too can have rich. intimate, deeply loving relationships within and without the body of Christ. They can have deep, loving, chaste same-sex friendships that can help restore the brokenness in their pasts. They can serve as surrogate aunts, uncles, grandmas, and grandpas for children who too are experiencing brokenness and loss. They deserve to be told that they are loved—not because of their sin—but, like the rest of us, despite it.

Our fallen, depraved world swims along the surface of a world so deep and wondrous, it's beyond even imagining. And this fallen, depraved world, that has no eyes to see and no ears to hear beyond the subjective, sensory, material life chatter cacophonously, filling the hearts and minds of people with beguiling lies that lead to eternal separation from a good and holy God. ## U.S. Senate Keeps Money Flowing to Planned Parenthood

## The United States **▲** Senate has voted to continue allocating federal taxpayer dollars to Planned Parenthood.

The Senate voted down a resolution previously approved by the U.S. House of Representatives which would have terminated funding for the nation's leading abortion provider.

U.S. Senators Dick Durbin and Mark Kirk voted to continue the flow of federal dollars to Planned Parenthood.

"This vote made clear which senators care more about the interests of the politically influential abortion lobby than the lives and safety of American women and families," said Charmaine Yoest, President of Americans United for Life.

Planned Parenthood clinics performed more than 332,000 abortions during 2009. Yoest points out that Planned Parenthood has announced plans to expand its abortion operations, mandating that every affiliate must have at least one abortion clinic within the next two years.

According to our friends at the Family

Research Council (FRC), despite being a billion-dollar-a-year corporation, Planned Parenthood receives \$363,200,000 annually—33 percent of its income—from "government grants and contracts," that is, from taxpayer dollars.

The victory for Planned Parenthood comes in the wake of extremely damaging recent information concerning Planned Parenthood's business practices. Undercover videos showed numerous Planned Parenthood clinics willing to collaborate with individuals engaged in human trafficking. Previous repulsive practices uncovered included a willingness to cover up cases of statutory rape, and a willingness to accept donations for the purpose of aborting black preborn children.

The U.S. House had previously voted in February to zero out federal funding of Planned Parenthood by a vote of 241-185. The Illinois Congressmen who sponsored the bill to halt federal appropriations to Planned Parenthood are: Rep. Randy Hultgren, Rep. Adam Kinzinger, Rep. Dan Lipinski, Rep. Don Manzullo, Rep.
