OPPOSE

HB 1 – La Shawn Ford (D): Permits sale and possession of hemp cannabinoids (which contain THC). **Status:** *in Rules Committee.*

HB 8 – La Shawn Ford (D): Lowers the age from 18 to 17 for a person to circulate election petitions. **Status:** *in Rules Committee.*

HB 41 – La Shawn Ford (D), SB 1733 – Lakesia Collins (D): Allows an incarcerated felon to vote. **Status:** *in Rules Committee.*

HB 64 – Sonya Harper (D): Promotes and regulates hemp products including those containing THC. **Status:** *in Rules Committee.*

HB 1055 – Dave Vella (D): Raises the amount of cannabis in possession that would be eligible for expungement of a violation record. **Status:** *in Rules Committee.*

HB 1064 – Daniel Didech (D), SB 78 – Adrienne Johnson (D): Authorizes a public library to construct, repair, operate, maintain, and regulate community mental health facilities. **Status:** *in Rules Committee.*

HB 1065 – Daniel Didech (D): Provides the Illinois Emergency Management Agency can make grants to public libraries. **Status:** *in Rules Committee.*

HB 1073 – Patrick Joyce (D) – senate sponsor: Requires college students to provide proof of 3 or more doses of diphtheria, tetanus, and pertussis vaccines not more than 10 years prior to enrollment. **Status:** *passed both Houses.*

HB 1083 – Changes gender references to gender neutral descriptions in the Religious Freedom Protecting Act, the Civil Unions Act, and the Rights of Married Persons Act. **Status:** *passed both Houses.*

HB 1143 – La Shawn Ford (D): Legalizes and declassifies psilocybin, a drug that causes markedly altered sensory perception leading to hallucinations, provides for “service centers” where people can get high. **Status:** *in Rules Committee.*

HB 1227 – Sonya Harper (D), SB 2212 – Willie Preston (D): Requires companies that contract with the state to disclose any past participation, even by a parent company, in slaveholding and be required to provide compensation to a Redress Fund. **Status:** *in Rules Committee.*

HB 1228 – Sonya Harper (D): Classifies cannabis and cannabis-infused products as “prescription and nonprescription medicine and drugs” and removes taxation on products purchased by a cardholder. **Status:** *in Rules Committee.*

HB 1288 – La Shawn Ford (D): After the completion of a convicted felony sentence, that person can be elected to public office. **Status:** *in Rules Committee.*

HB 1374 – Rep. Jennifer Gong-Gershowitz (D): Requires doctors performing health exams on children to question the child on the safe storage of firearms practices within the home. **Status:** *in Rules Committee.*

HB 1398 – Rep. Maura Hirschauer (D): Requires the Illinois Department of Public Health to **ensure** that doctors performing health exams on children be required to question the child on the safe storage of firearms practices within the home. **Status:** *in Rules Committee.*

HB 1429 – Kevin John Olickal (D): Prohibits the state or local governments from imposing fines against homeless individuals for occupying public property. **Status:** *re-referred back to the Rules Committee.*

HB 1442 – Nabeela Syed (D): Provides that election authorities “shall” instead of “may” establish curbside voting during early voting periods. **Status:** *in Rules Committee.*

HB 1601 – Will Guzzardi (D): Authorizes all counties to impose a gasoline tax (rather than only DuPage, Kane, Lake, Will, McHenry). **Status:** *in Rules Committee.*

HB 1708 – Kam Buckner (D): Municipalities may adopt ranked-choice voting for local elections. **Status:** *in Rules Committee.*

HB 1786 – Maura Hirschauer (D): Creates a task force to study the possibility of implementing ranked-choice voting beginning in 2029. **Status:** *in Rules Committee.*

HB 1815 – Curtis Tarver (D): Expungement of records of a minor if that minor has committed an act which if committed by an adult would constitute a criminal violation of the Cannabis Control Act or Drug Paraphernalia Control Act. **Status:** *in Rules Committee.*

HB 1929 – Camille Lilly (D): Amends the Human Rights Act. Makes it a civil rights violation for any person to inquire into another person's criminal conviction record prior to making a conditional offer to sell, lease, or rent property to that person; and to refuse to sell, lease, or rent the property. **Status:** *rereferred back to the Rules Committee.*

HB 2381 – Laura Faver Dias (D): Requires 4 hours of LGBTQ+ inclusivity training for all school board members. **Status:** *in the Rules Committee.*

HB 2431 – Nabeela Syed (D): Establishes ranked-choice voting for Illinois executive officers. Provides that votes proceed in rounds until a winner is found. **Status:** *in Rules Committee.*

HB 2679 – Rep. Margaret Croke (D): Amends the Criminal Code to protect abortion clinics as “vital public facilities” (but *not* churches or pregnancy care centers) from “terrorist acts.” Catholic Vote tracks abortion activist attacks on Catholic churches. They have recorded over 400 since 2020. In the last year 90 pregnancy care centers have been set on fire, firebombed and vandalized. In addition, peaceful protesters have been arrested and sentenced to jailtime. **Status:** *in Rules Committee.*

HB 2706 – Lisa Hernandez (D), SB 2305 – Omar Aquini (D): Amends the Illinois Trust Act to strengthen, in a number of ways, the ban on Illinois law enforcement officers from cooperating in any way with federal immigration officials. **Status:** *in Rules Committee and Assignments Committee respectively.*

HB 2718 – Maurice West (D), SB 1484 – Omar Aquino (D): Creates the Facilitating Voting By All Eligible Citizens Act. Requires all citizens to vote in a general election regardless of whether they are registered to vote. **Status:** *in Rules Committee.*

HB 2723 – Abdelnasser Rashid (D), SB 2462 – Mike Porfirio (D): Anti-Israel bills that allow companies boycotting Israel to do business with our pension system that were previously prohibited. **Status:** *in Rules & Assignments Committees respectively.*

HB 2793 – Rep. Nicholas Smith (D): Amends the School Code. Teacher evaluation ratings on record as “unsatisfactory” will be considered “ineffective,” while “excellent,” “proficient,” or “needs improvement” will be considered “effective.” **Status:** *in Rules Committee.*

HB 2827 – Terra Costa Howard (D): Homeschooled students must register with the local public school; requires proof of immunizations, parent teachers must prove a high school education. Failure could result in fines and jailtime. **Status:** *passed out of committee but the sponsor was unable to get the 60 votes needed at this time to call it for a vote in the House.*

HB 2904 – Rep. Dagmara Avelar (D): Creates the Health Care Transparency Act. Provides that the Department of Public Health shall identify reproductive health care services, LGBTQ health care services, and end-of-life health care services and develop an education and awareness program regarding how denial of care may negatively impact health care access and quality. (Ironically, the aforementioned services end life, not provide access to quality healthcare.) **Status:** *in Rules Committee.*

HB 2929 – La Shawn Ford (D): Collect research and data on the effectiveness of “Overdose Prevention Sites” that actually offer “pre-obtained substances;” ... “sterile injection or other substance use supplies” and “safer smoking and safer snorting kits.” Grants immunity from civil and criminal liability. Why would immunity be needed?! **Status:** *passed out of committee, but was rereferred back to the Rules Committee.*

HB 2960 – Rep. Laura Faver Dias (D): Requires public school health education courses to include instruction in mental health and keeps pupil's health or mental health information confidential from everyone, which would include parents. The bill states that students would be given instruction on how to find help from professionals within the school. Are these the same professionals that are telling students they can be a girl or a boy? Or they can have sex with whomever they choose? The same ones that are keeping from parents when a student wants to change genders (as if that's even possible)? Or using the student's name and pronouns of their choice without the parent's knowledge? **Status:** *passed out of committee, but was rereferred back to the Rules Committee.*

HB 2992 – Rep. Theresa May (D): Creates the Healing Opportunities through Psilocybin Equity Pilot Program Act. Psilocybin is a hallucinogenic found in a certain variety of mushrooms. It produces hallucinations. Notice the name of the bill. It's straight out of the “medical” marijuana playbook. HB 2992 provides immunity from criminal and civil liability for licensees with respect to manufacturing, delivery, and possession of psilocybin products. If this is good for Illinois, why would they need an immunity from liability clause? **Status:** *in Rules Committee.*

HB 3023 – Margaret Croke (D): Allows for a \$10,000 award and attorney fees for private cause of action to be filed by a person who merely “fears that, ... violence will be committed against them...” **Status:** *passed out of committee, but was rereferred back to the Rules Committee.*

HB 3049 – Mary Edly-Allen (D) – senate sponsor: Allows 2 people to marry themselves without an officiant. **Status:** *passed in House; in Senate Assignments Committee.*

HB 3055 – Barbara Hernandez (D): Prohibits denial of a state grant or scholarship to an illegal student. **Status:** *in Rules Committee.*

HB 3057 – Sonya Harper (D): DEI policies to be implemented in State-supported institutions of higher learning. **Status:** *in Rules Committee.*

HB 3061 Sonya Harper (D), HB 3513 Justin Slaughter (D), SB 1772 – Kimberly Lightford (D): Allows for counties/municipalities to be issued a temporary event license to sell marijuana and cannabis paraphernalia. **Status:** *House bills in Rules Committee, Senate bill was rereferred back to Assignments Committee.*

HB 3163 – Jaime Andrade (D): Makes it a Class 3 felony for anyone to disclose personal information of an abortionist. **Status:** *passed out of committee but was rereferred back to Rules Committee.*

HB 3247 – Karina Villa (D): prohibits public schools from denying free education and programs to students that are here illegally; allows aggrieved parties to file civil lawsuits and be awarded damages. **Status:** *passed both Houses.*

HB 3279 – Anna Moeller (D), SB 1846 – Graciela Guzman (D): Provides state covered abortion services to illegals. **Status:** *in Rules and Assignments Committees respectively.*

HB 3287 – Hoan Huynh (D), HB 3780 – Barbara Hernandez (D): Provides healthcare for all. **Status:** *in Rules Committee.*

HB 3315 – Rita Mayfield (D): Prohibits mental health professionals from counseling adults who want to overcome same-sex attraction and gender identity confusion. **Status:** *in Rules Committee.*

HB 3355 – Carol Ammons (D): Election authorities may mail all qualified voters vote by mail ballots. **Status:** *in Rules Committee.*

HB 3489 – Rachel Ventura (D) senate sponsor: Redefines the “practice of pharmacy” to include assessment and consultation of patients and the dispensing of emergency contraception, otherwise known as the morning after pill, an abortifacient, and be paid for by tax dollars through Medicaid. **Status:** *passed both Houses.*

HB 3518 – Will Guzzardi (D), SB 2391 Celina Villanueva (D): Decriminalizes/legalizes prostitution and expunges criminal records. **Status:** *in Rules Committee & Assignments Committee respectively.*

HB 3626 – Justin Slaughter (D): Permits expungement of prostitution charges. **Status:** *in Rules Committee.*

HB 3637 – Karina Villa (D) – senate sponsor: Amends numerous health care laws. Prohibits the Illinois Department of Health from taking disciplinary action against a person who has had their license, registration, and/or permit revoked from another state as a result of violating the state’s laws against certain procedures, such as abortions. Additionally, a drug **not** approved by the Food & Drug Administration, but one that has been recommended by the World Health Organization shall **not** be deemed an adulterated drug, even if the drug’s labelling reflects prior approval that is no longer in effect. **Status:** *passed both Houses.*

HB 3709 – Celina Villanueva (D) – senate sponsor: Mandates that public colleges and universities provide access to health care professionals who prescribe contraception and abortion pills; allows university pharmacies to dispense contraception and abortion pills. Removes the requirement that the university pharmacy enter into a referral agreement with a tertiary medical care facility with obstetrics and gynecological services in the event of complications. **Status:** *passed both Houses.*

SB 9 – Linda Holmes (D): Termed “End-of Life Options for Terminally Ill Patients Act,” it legalizes lethal drugs by a physician for the purpose of ending one’s life. **Status:** *See SB 1950*

SB 20 – Kimberly Lightford (D): Regulates the manufacturing and sale of “hemp-derived intoxicating products” .. “after which the product is considered cannabis.” **Status:** *in Assignments Committee.*

SB 42 – Curtis Tarver (D) – house sponsor: Prohibits law enforcement from stopping and inspecting a car based on the odor of cannabis; removes the requirement of storing cannabis in an odor-proof container. **Status:** *passed in the Senate and out of a House Committee, but was sent back to the Rules Committee.*

SB 1224 – Lakesia Collins (D): Creates the Fantasy Sports Consumer Protection Act as another way to expand and tax gambling. **Status:** *rereferred back to the Assignments Committee.*

SB 1259 – Graciela Guzman (D): Mandates insurance coverage for standard fertility preservation services such as IVF. **Status:** *rereferred back to the Assignments Committee.*

SB 1266 – Karina Villa (D): An illegal immigrant can file a petition, with no time limitations, to void a conviction or sentence due to his/her inability to understand the adverse immigration consequences of the conviction. **Status:** *in Assignments Committee.*

SB 1516 – Mike Simmons (D): Fees for a State ID shall be waived for a transgender person and family from out of state fleeing persecution. **Status:** *in Assignments Committee.*

SB 1520 – Kimberly Lightford (D): Provides state loans and grants for cannabis businesses, including loan forgiveness, to “social equity applicants.” **Status:** *deadline was extended to June 1, 2025.*

OPPOSE *continued...*

SB 1565 – Mary Edly-Allen (D): Allows civil action including libel and defamation for distribution of political materials to affect the outcome of a campaign. **Status:** *in Assignments Committee.*

SB 1638 – Adriane Johnson (D): Allows expungement or sealing of certain criminal offenses to prevent extradition to another state. **Status:** *in Assignments Committee.*

SB 1810 – Willie Preston (D): Training opportunities for educators to teach Black English. **Status:** *in Assignments Committee.*

SB 1881 – Karina Villa (D): Bans schools and employees from cooperating with federal immigration officials. **Status:** *in Assignments Committee.*

SB 1950 (House Floor Amendment 2) – Robyn Gabel (D): Legalizes physician-assisted suicide by lethal drugs. **Status:** *The language was taken from SB 9, attached as an amendment in the House and passed, but it wasn't called for concurrence in the Senate before the end of session and for that we are thanking God!*

SB 1995 – Graciela Guzman (D): Prohibits a data collector from disclosing immigration status of an Illinois resident. **Status:** *in Assignments Committee.*

SB 2004 – Laura Murphy (D): Allows ranked-choice voting. **Status:** *referred back to the Assignments Committee.*

SB 2033 – Celina Villanueva (D): The Attorney General shall publish policies that limit assistance with immigration enforcement to the fullest extent possible, and provides “safe zones” which include schools, libraries, hospitals, nursing homes. **Status:** *in Assignments Committee.*

SB 2065 – Karina Villa (D): Provides free education for illegals. Prohibits the school from disclosing immigration status to immigration agencies. **Status:** *in Assignments Committee.*

SB 2158 – Rachel Ventura (D): Any 2 candidates, regardless of party affiliation, who receive the most votes in a primary election shall proceed to the general election ballot. **Status:** *deadline extended to June 1, 2025.*

SB 2251 – Ram Villivalam (D): Amends the Human Rights Act to prohibit discrimination based on immigration status. **Status:** *in Assignments Committee.*

HB 52 – Charles Meier (R), HB 2643 – Martin McLaughlin (R): If a bill/amendment is incorporated into a new bill/amendment number, the witness slips filed previously will remain with the new bill/amendment number.

HB 1029 – John Cabello (R), HB 1217 – Adam Niemerg (R), HB 1317 – C.D. Davidsmeyer (R), HB 1345 – Paul Jacobs (R), SB 1316 Terri Bryant (R): Repeals the Illinois Trust Act which prohibits local law enforcement from cooperating with federal immigration enforcement.

HB 1033 – John Cabello (R): Repeals the Illinois law that allows non-citizens to become police officers.

HB 1037 – John Cabello (R): Increases penalties for knowingly selling or giving a firearm to a convicted felon or gang member.

HB 1038 – John Cabello (R): Increases penalties for manufacturing, delivering, or possessing 15 grams or more of any substance containing fentanyl.

HB 1042 – John Cabello (R): Requires a convicted sex offender to wear an electronic monitoring device for the first five years after registering as a sex offender.

HB 1049 – John Cabello (R): Requires a person found guilty of a DUI, where the violation resulted in a death, the person shall pay child support determined by the court to the children of the victim.

HB 1103 – Jed Davis (R): Creates the Online Age Verification for Material Harmful to Minors Act; violators subject to civil liability for damages, attorneys fees, and costs.

HB 1105 – Jed Davis (R): Requires blood banks to test for and blood donors to disclose a COVID-19 or other mRNA vaccine.

HB 1111 – Jed Davis (R) and HB 1121 – Kevin Schmidt (R), HB 1454 – Amy Grant (R), HB 1498 – Chris Miller (R), HB 2623 – Adam Niemerg (R): Requires the county clerk to issue death record certifications and cancel the voter registration of anyone that died during the preceding month.

HB 1117 – Regan Deering (R) and HB 1216 – Adam Niemerg (R): Requires school female athletic teams to allow only females based on biological sex and vice versa; prohibits a government entity from adverse actions against the school.

HB 1130 – Charles Meier (R): Requires notifications to jury administrators and local election authorities of returned summons indicating change of address, requires county clerks and Board of Election to certify accuracy of voter registration rolls.

HB 1135 – Paul Jacobs (R), HB 2618 – Adam Niemerg (R): A child born alive as a result of abortion shall be given care and protection under the law.

HB 1139 – Travis Weaver (R), HB 1336 – Paul Jacobs (R), HB 2624 – Adam Niemerg (R): Creates the Parental Notice of Abortion Act of 2025.

HB 1140 – Jed Davis (R), SB 284 – Sue Rezin (R): Prohibits a person charges with sex trafficking/grooming a minor from plea bargaining to a lesser charge.

HB 1161 – Chris Miller (R): Creates the Safety and Opportunity for Girls Act by prohibiting the restriction of state funds to a school that provides separate sex-segregated bathrooms and locker rooms.

HB 1209 – David Friess (R): Requires state data collection to classify students as either male or female at birth.

HB 1214 – Adam Niemerg (R), HB 3819 – Tom Weber (R): Prohibits all sex-reassignment procedures on minors.

HB 1220 – Chris Miller (R): Amends the Reproductive Health Act by requiring a 24 hour waiting period before an abortion, and written acknowledgment that specific information and material has been provided.

HB 1266 – John Cabello (R): Establishes the Department of Government Efficiency (DOGE) to weed out unnecessary and redundant laws, rules, and agencies that “make conducting business in this State more difficult than necessary.”

HB 1269 – Rep. John Cabello (R): Requires parental permission before a student under 18 can participate in a self-report survey that may reveal personal, protected information; requires the school to allow the parent to review the questions to be asked.

HB 1333 – Paul Jacobs (R): Repeals the Reproductive Health Act and creates a number of Pro-Life Acts.

HB 1342 – Paul Jacobs (R), HB 2649 – Martin McLaughlin (R), HB 3147 – Blaine Wilhour (R): Reinstates permanently the Invest in Kids Act, a scholarship program for underprivileged families to send their children to private schools.

HB 1401 – John Cabello (R), SB 261 – Jill Tracy (R): Repeals the portion of the law that authorizes the government (and others) to enforce COVID-19 restrictions.

HB 1404 – Dan Ugaste (R): Reinstates cash bail and other Criminal Code provisions.

HB 1467 – Nicole La Ha (R): Deletes the affirmative defense that the person thought the prostitute was over 18.

HB 1469 – Nicole La Ha (R): Adds involuntary sexual servitude of a minor to the Sex Offender Registration Act.

HB 1472 – Travis Weaver (R): Creates the offense of coercing an abortion.

HB 1476 – Patrick Windhorst (R): Adds to the Criminal Code of 2012 knowingly making a video of a person’s intimate parts when the person is under 18-yrs-old.

HB 1478 – Patrick Windhorst (R): Adds to the Criminal Code of 2012 strong felony charges when knowingly exposing a child under 18 to fentanyl.

HB 1539 – Tony McCombie (R), HB 1769 – C.D. Davidsmeyer (R): Voter ID required to vote.

HB 1735 – Regan Deering (R): Any non-citizen who votes in an election is guilty of a Class 3 felony.

HB 1742 – Dennis Tipsword (R): Voter ID required to vote; mailed ballots will require a 3-judge panel to verify signatures, allows for certain provisions if mailed ballot was rejected.

HB 1744 – Joe Sosnowski (R): No marriage under age 18.

HB 1748 – Joe Sosnowski (R): Requires all original or amended GA bills to remain on the calendar for 5 days before they can be voted on.

HB 1792 – Tom Weber (R): Prohibits the Department of Public Health and schools from requiring children to receive a COVID-19 shot.

HB 1795 – Tom Weber (R): Amends numerous professional agency statutes to require verification of criminal history in order to obtain or renew a license to practice in that field.

HB 1845 – John Cabello (R): Creates the Illinois Rights of Conscience Act, protecting a person’s right to refuse to speak, create art, perform or participate in a service that is contrary to that person’s conscience.

- HB 2400 – Rep. Michael Kelly (D):** Classifies aggravated criminal sexual assault as a Class X felony for which 5 years shall be added to the term of imprisonment and predatory criminal sexual assault of a child as a Class X felony with a minimum term of imprisonment of 11 (rather than 6) years.
- HB 2416 – Patrick Windhorst (R):** Amends the Vehicle Code. Clarifies the prohibition of a person driving under the influence of cannabis that renders the person incapable of driving safely.
- HB 2597 – Adam Niemerg (R):** Creates the COVID-19 Religious Exemption Act. Prohibits discrimination against an individual who refuses to accept a COVID-19 vaccination; allows for civil actions.
- HB 2600 – Adam Niemerg (R):** Creates the COVID-19 Vaccination Employer Mandate Prohibition Act. Prohibits an employer from requiring proof of vaccine.
- HB 2606 – Adam Niemerg (R):** Creates an income tax credit equal to 50% of the amount donated to a qualifying pregnancy resource center that provides assistance to pregnant women to carry to term.
- HB 2607 – Adam Niemerg (R):** Creates the Campus Free Speech Protection Act. Sets forth prohibited and permissible conduct.
- HB 2611 – Adam Niemerg (R):** Creates the Education Savings Account Program to provide grants in the amount that would have been provided to the local school district had the student enrolled, for qualifying expenses.
- HB 2613 – Adam Niemerg (R):** Reduces the gasoline tax to 19 cents per gallon (currently 39.2 cents). Prohibits an increase
- HB 2620 – Adam Niemerg (R):** Requires a 72 hour waiting period before a woman/girl can have an abortion, after being given information on risks.
- HB 2622 – Adam Niemerg (R):** Creates the Born Alive Infant Protection Act. Requires an abortionist to use a method that will best preserve the life of the older fetus; failure results in a Class 3 felony; and other provisions.
- HB 2823 – Chris Miller (R), SB 2079 – Andrew Chesney (R):** It prohibits a student athlete from participating in a sports program designated for the opposite sex.
- HB 2915 – Joe Sosnowski (R), HB 1204 – David Friess (R):** Amends the Interscholastic Athletic Organization Act. A team or sport designated for females may only have females on the team.
- HB 2943 – Ryan Spain (R):** Reduces annual minimum salary of lawmakers from \$85,000 to \$28,000; salaries for executive officers will be set by the Compensation Review Board.
- HB 3227 – Tom Weber (R), SB 1699 – John Curran (R):** Requires identifying money appropriated to illegals.
- HB 3243 – Adam Niemerg (R):** Repeals several abortion-related laws; creates several pro-life laws.
- HB 3244 – Adam Niemerg (R):** Requires the Auditor General to post an audit of funds covering state funded abortions.
- HB 3666 – Tom Weber (R):** Requires reporting when a health care provider prescribes puberty blockers to anyone under age 18.
- HB 3736 – Bob Rita (D):** Allows for someone harmed by the unlawful sale of obscene material to file a civil action with damages up to \$10 million for each count.
- HB 3852 – Adam Niemerg (R):** Bans Partial Birth Abortion.
- HJRCA 1 – Charles Meier (R):** Amends the Legislature Article of the Illinois Constitution pertaining to how senate and representative districts are drawn.
- HJRCA 2 – John Cabello (R):** Amends the Bill of Rights Article of the Illinois Constitution to support and clarify the 2nd Amendment's right to bear arms.
- HJRCA 3 – David Friess (R):** Amends the General Provisions Article of the Illinois Constitution by requiring parental notice of abortion on a minor girl.
- HJRCA 4 – Dan Ugaste (R):** Amends the Suffrage and Elections Article of the Illinois Constitution by establishing procedures for the recall of elected state officials.
- HJRCA 5 – Ryan Spain (R):** Amends the Legislature Article of the Illinois Constitution by replacing the current method of legislative redistricting and other provisions.
- SB 48 – Sue Rezin (R) and HB 1162 – Chris Miller (R):** Prohibits the purchase of Illinois property by Communist China.

SB 49 – Sue Rezin (R): A social media company in the State must provide a free service where a customer can report illegal content.

SB 54 – Seth Lewis (R): The State Board of Elections shall make available to the public the number of votes and vote by mail ballots in every primary and general election. *Status: in Executive Committee.*

SB 59 – Steve McClure (R): When issuing a driver's license, the Secretary of State shall verify that the person is a U.S. citizen and prohibit that person from registering to vote.

SB 156 – Terri Bryant (R) and HB 1129 – Charles Meier (R): Creates the Dignity for Aborted Children Act, requiring abortionists to provide consent forms for the disposal of the fetus and submit reports to the General Assembly on the number of abortions, procedure type, and method of disposal.

SB 165 – Terri Bryant (R), HB 1340 – Paul Jacobs (R), HB 2619 – Adam Niemerg (R): Creates the Ultrasound Opportunity Act, requiring an abortionist to offer an ultrasound of the baby prior to an abortion.

SB 168 – Terri Bryant (R): Lays out sex and other offenses that would revoke a teacher's license.

SB 172 – Michael Halpin (D): Prohibits a foreign national from contributing money to a ballot initiative for the purpose of influencing public policy.

SB 181 – Chapin Rose (R): Requires Voter ID or photo ID; changes registering to vote from day of election to 7 days prior; secure tracking of all printed ballots; removes permanent vote by mail and other provisions.

SB 280 – Sally Turner (R): Unlawfully selling or dispensing any scheduled drug containing a detectable amount of fentanyl is a Class X felony.

SB 299 – Neil Anderson (R), SB 1200 – Andrew Chesney (R): Reinstates the death penalty under certain conditions.

SB 1202 – Andrew Chesney (R): Prohibits any law enforcement entity from refusing to cooperate with the enforcement of federal immigration laws.

SB 1226 – Andrew Chesney (R): School districts shall restrict access to restrooms, locker rooms and dressing rooms based on biological sex.

SB 1227 – Andrew Chesney (R): Requires schools to provide a list of the curriculum on their website.

SB 1243 – Andrew Chesney (R): Prohibits the GA from voting on legislation between 12:00 a.m. and 6:00 a.m.

SB 1313 – Neil Anderson (R): Amends the TRUST Act. Local law enforcement can notify immigration agents of illegals convicted of a crime under Illinois law.

SB 1381 – John Curran (R): Requires a searchable database of a school library's materials be made available online to parents.

SB 1783 – Chris Balkema (R): Prohibits government sponsored sexual performances.

SB 2078 – Andrew Chesney (R): Repeals the co-ed multi-occupancy bathroom law; requires all state identification documents to reflect the person's biological sex.

SB 2224 – Terri Bryant (R): Maintains the electoral college.

SB 2358 – Jason Plummer (R): Protecting Religious Assembly in State of Emergency Act (PRAISE) protects churches from government edicts; allows civil action.

SJRCA 1 – Chapin Rose (R): Amends the Illinois Constitution by setting term limits. ■
