### from the Executive Director — David E. Smith

Racial tensions are at a sustained heightened level in America. In response to the horrific death of George Floyd, we witnessed violent physical attacks and wanton destruction of public and private property. What we did not hear much of from those we have placed in authority were rational discussions to stop it.

Decades of indoctrination, the vilification of American culture, and the embrace of what some falsely consider "rights" have brought us to a critical moment in our nation's history.

Now, fringe elements dictate policy by means of mob action rather than through the democratic process. Professional sport leagues and corporate America choose left-wing "woke" messages to earn their social justice stripes.

Today, hundreds of thousands of people are walking in the darkness of sin because they regard themselves more highly than others and persistently harbor racism and hatred in their heart.

Scripture unequivocally describes the human condition that affects us <u>all</u>: "The heart is deceitful above all things, and desperately wicked; who can know it?" (Jer. 17:9)

A wicked heart — an unregenerate heart — deceives people into believing the vile propaganda of groups such as the KKK, Black Lives Matter, Antifa, and Neo-Nazis. The flawed thinking that purports that one group of humans is intrinsically more valuable than any other group leads to direct or indirect prejudices, discrimination, and hostility - even violence targeted at fellow human beings. These iniquitous feelings, thoughts, and beliefs that are exalted against the knowledge of God, whether conscious or subconscious, must be eradicated. (2 Cor. 10:5) Or our Christian testimony is worthless.

Therefore, for the good purpose of training our deceitful hearts, Scripture instructs us to do ALL things without complaining, bitterness or resentment. (Phil. 2:14-16; Heb. 12:15) It exhorts us to do ALL things in love and for the glory of God. (1 Cor. 16:14; 1 Cor. 10:31) And God's Word encourages us to be content in ALL things, standing firm in the work of the Lord and seeking first His kingdom. (1 Tim. 6:6; 1 Cor. 15:58; Matt. 6:33)

Clearly, we must be immersed in the Word of God in order for our hearts to align with His perfection. We must think biblically about our condition, seeing ourselves and others as our Father see us, and we must pursue true biblical love as defined in 1 Corinthians 13. Consider these verses:




Brothers and Sisters in Christ, individually and corporately, we must devote ourselves to the pure Word of God and to prayer! \*

Idaho's law, which prohibits transgender females from competing against biological females, was challenged in federal court by the ACLU. In announcing the statement, Attorney General William Barr said "Allowing biological males to compete in all-female sports is fundamentally unfair to female athletes...Under the Constitution, the Equal Protection Clause allows Idaho to recognize the physiological differences between the biological sexes in athletics." ★

# SCOTUS: Casinos Open, Churches Restricted



In what many thought would be an open and shut case in favor of churches, the Supreme Court of the United States (SCOTUS) shocked observers when it refused to intervene in a Nevada dispute between churches and that

state's governor, Steve Sisolak. Governor Sisolak opened casinos to thousands of patrons but limited churches to 50 members. Calvary Chapel sued the state, saying the governor's action was

clearly a violation of the First Amendment and discriminated against churches. Five justices, including Chief Justice Roberts, refused to hear the case, leaving the state's action standing. In a scathing dissent, Justice Neil Gorsuch wrote:

"The world we inhabit today, with a pandemic upon us, poses unusual challenges. But there is no world in which the Constitution permits Nevada to favor Caesars Palace over Calvary Chapel." ★



# A Better Education Option for Your Children

hristian parents, grandparents and church leaders must seriously consider other options for their students and make the move away from government schools. The prevalence of perversion, subversion and indoctrination are becoming more prevalent, so to protect the hearts and minds of our children, it is wise to consider other education options.

## **SCOTUS Expands School Choice Opportunities**

The High Court opened new avenues of funding for religious schools when it declared in June that a Montana school tax credit program unfairly discriminated against religious schools. Montana and over twenty other states prohibited directly or indirectly funding religious education. In Montana's case, the state created a tax credit that allowed donors to pay money to the state and receive a tax credit. That money was then distributed to low-income families to allow them to send their children to any non-public school as long as it was not a religious non-public school.

In a 5-4 decision, the Court ruled that the school tax credit program was in violation of the Free Exercise Clause. According to the National Review, this decision "will allow states throughout the U.S. to provide assistance to families for private school through the creation of schoolchoice programs, including vouchers, tax scholarship programs, and education-savings accounts (ESAs)." ★

## Please **Pray...**



### GENERAL ELECTION: NOVEMBER 3, 2020



**CLOSE OF REGULAR REGISTRATION**: Last day for registration or transfer of registration within the offices 6 of the election authority.

**GRACE PERIOD REGISTRATION AND VOTING**: First day for grace period registration and grace period voting in the office of the election authority or at a location designated for this purpose by the election authority.

**CLOSE OF ONLINE VOTER REGISTRATION**: Last day for voters to register to vote through the State Board of Elections website. NOVEMBER 2020

29 Last day for Election Authority to receive Vote By Mail application.

EARLY VOTING-OFFICE OF THE ELECTION AUTHORITY: Last day for early voting at the office of the election authority or at a location designated by the election authority for this purpose for the Primary Election.

GRACE PERIOD REGISTRATION AND VOTING: Last day for grace period registration and grace period voting in the office of the election authority or at a location designated for this purpose by the election authority.
