Efforts to stop the legalization of physician-assisted suicide in Illinois are reaching a critical juncture. The vote count is extremely close, and now—more than ever—we need people of faith and conviction to stand up and be heard. (Mat. 5:13-16)

- Human life is sacred. Scripture tells us that every person is created in the image of God (Genesis 1:27), and thus each life holds immeasurable value—regardless of age, ability, or health. Our worth is not determined by our productivity or perceived quality of life, but by our identity as God’s creation.
- The commandment “Thou shall not kill” (Exodus 20:13) affirms the sanctity of life and the moral imperative to protect it. While some may try to draw distinctions between murder and assisted suicide, both involve the intentional ending of a human life. Facilitating or encouraging suicide does not remove moral responsibility—it only shifts it.
- Legalizing assisted suicide opens the door to dangerous consequences. Vulnerable individuals—especially the elderly, disabled, or those struggling with spiritual and/or mental issues (or challenges)—could feel pressure to end their lives. What begins as a “right to die” often becomes a subtle expectation—or even a perceived “duty”—to die.
