A Pro-Life Letter

In October 2025, a group of 51 Republican U.S. Senators sent a powerful letter to the U.S. Department of Health and Human Services (HHS) Secretary **Robert F. Kennedy Jr.** and FDA Commissioner **Dr. Martin Makary**, urging a reevaluation of the approval of a generic version of mifepristone, the leading drug used in chemical abortions.

The letter expressed deep concern that the FDA's approval of the generic drug was inconsistent with the agency's stated commitment of reviewing safety data discrepancies and conducting a comprehensive reassessment of abortion pill safety, saying

The "abortion-on-demand" culture enabled by the Biden-Harris administration's removal of critical safeguards on the only FDA-approved abortion regimen is currently the biggest threat to unborn life in America today.

These pro-life federal lawmakers emphasized that unrestricted access to abortion pills undermines state pro-life laws, as thousands of doses are shipped monthly into states that have restricted abortion access following the *Dobbs* decision.

They urged the suspension of the generic mifepristone's approval, reinstatement of the in-person dispensing requirement, and withdrawal of FDA guidance allowing pharmacy distribution without adequate medical supervision.



The letter cited research indicating that over 10% of women using mifepristone experience serious adverse events such as hemorrhaging, infection, or sepsis, contradicting claims that the pill is safer than over-the-counter medications.


They ended their letter with this emphatic statement

We are committed to continuing to work together to give a voice to the voiceless and protect women from the dangerous effects of unregulated access to chemical abortion drugs. The life, safety, freedom, and health of millions of Americans, born and unborn, depend on it.

U.S. Senators **Susan Collins** (R-Maine) and **Lisa Murkowski** (R-Alaska) did not sign the letter, making them the only Republican senators not to join the effort. ✦

It's Not Too Late: A Story of Abortion Pill Reversal

Emily was only 19 when she found out that she was pregnant. Most 19-year-olds are preparing for college.

Not Emily — well, not anymore. She was staring at two bright pink lines on her at-home pregnancy test.

She was terrified. What were her parents going to think? How was she going to support a baby on her part-time work salary? How was she going to continue college?

With fear driving her, she drove to **Planned Parenthood**. The first thing the nurse at Planned Parenthood had her do was sign waivers releasing PP from any legal responsibility if something were to go wrong. After all, the side effects linked to the abortion pill are startling.

Finally, the nurse handed her the first dose of the abortion pill, mifepristone. Emily recounts,

"I didn't know it then, but this pill would cut off the baby's food supply and cause him to stop growing and thriving. I stared at the pill in my hand and became overwhelmed with sadness and the feeling that I was making a terrible mistake. But yet again, the fear I had of being pregnant overcame all other emotions, and I took the pill."

So many stories end there. So many lives end there. But not Emily's story. Not her baby's life.

On the drive home, Emily was overwhelmed with sadness and guilt. She regretted her decision to end her baby's life.

"Ironically, it also poured rain the entire night. I felt like Jesus was crying for what I had done."

When she got home, Emily confided in her sister that she had just taken her first abortion pill but regretted her decision.

That night, Emily and her sister scoured the internet for answers — was there a way to reverse the deadly path that Emily had begun?

Eventually, they came across a website discussing the abortion reversal pill. The website had a hotline nurse available, so Emily called the number.

While the nurse was finding resources for Emily in her area, Emily prayed for her baby.

"I felt like my soul was crying and pleading with the Lord on behalf of my baby's life."

Less than 12 hours after Emily had taken her abortion pill, she took her first dose of the abortion reversal pill.

For clarification, the first dose of the abortion pill (mifepristone) blocks progesterone from being absorbed by the womb. Progesterone is necessary for developing babies because it strengthens and maintains the uterine lining, reduces contractions, and prevents miscarriage. When this hormone is not allowed to reach the baby, the baby loses all stability and protection.



The abortion reversal pill floods the uterus and womb with progesterone—rushing to the aid and protection of the baby.

The abortion reversal pill is only effective if it is taken in less than 24 hours of the abortion pill and if the recipient has only taken the first dose (the reversal is ineffective if the second abortion pill, misoprostol, has been taken.)

By God's grace, Emily (and her baby) had made it in time.

"I think a common misconception about babies and one that the abortion industry loves to promote, is that young babies in utero are only cells and aren't real people. This is entirely untrue and when I saw that [six week] model I couldn't believe that I almost ended my little baby's life."

That following July, Emily gave birth to a healthy baby boy weighing 9.5 pounds.

She named him Ezekiel, which means "God strengthens" because that is exactly what God did. He protected little Ezekiel from the abortion pill and its harmful intent.

"I am for ever changed into a new person because of my son and what I went through to bring him into this world. He is the absolute best thing that has ever happened to me, and I am so blessed to have him as my son. God says children are a blessing and a gift from above, and I cannot agree more. I hope everyone, when faced with this choice, chooses life, but thankfully, if they make a mistake like mine, there's a second chance, which is the reversal process."

Emily and Ezekiel's story is just one of many.

Gambling Corruption

On the national front, the FBI and Department of Justice recently announced the arrest of dozens of individuals in a massive, tech-driven gambling bust involving organized crime families and personnel connected to the National Basketball Association (NBA).

For years, IFI and other Christian organizations have warned that legalized gambling would corrupt professional sports and politicians and victimize hardworking citizens—and that’s exactly what’s happening. The line between competition and corruption grows thinner every year as scandals erupt across leagues, lawmakers grow cozy with casino lobbyists, and families are torn apart by addiction and debt.

What was marketed as “harmless entertainment” has become a moral and social cancer—one that preys on human weakness and erodes the integrity of our culture.

A quick, informal poll of friends and social media followers revealed that no one was surprised by the FBI’s announcement. Many believe the corruption reaches far

beyond the NBA—and they’re probably right.

According to a 2024 article from WGLT, about 4% of Illinois adults suffer from a gambling disorder, while another 7% are at risk. That’s more than 1.1 million people across our state whose lives and families hang in the balance.

Since the U.S. Supreme Court’s decision in 2018 allowing states to legalize and regulate sports betting, the gambling industry has exploded. What we’re witnessing is the inevitable result of normalizing an industry built on exploitation and addiction.

According to a CNN report in June 2024, at least 23 professional players or coaches have been suspended or permanently banned from their leagues for sports betting violations since 2018, and these are only the cases that have been discovered.

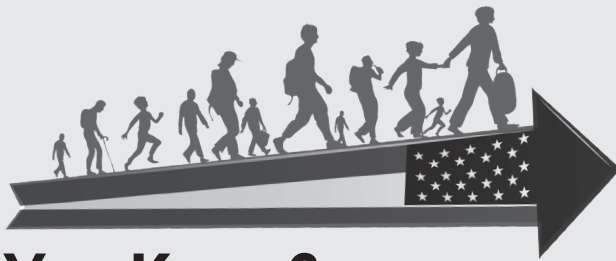
Practically every television broadcast now features betting odds and parlay promotions. Sports betting commercials are unrelenting and offer hundreds of



dollars as an enticement to new sports wagering platform users. Our culture has systematically normalized an industry that destroys families, fuels addiction, and, as this case demonstrates, provides fertile ground for corruption at the highest levels of professional sports.

FBI Director Kash Patel and the many law enforcement agencies and personnel involved in these enforcement operations deserve credit, but law enforcement cannot solve a problem that society has so enthusiastically embraced. Until our culture recognizes gambling for what it truly is—an exploitative industry that preys on human weakness and breeds corruption—we will be unwilling and unable to correct it.

Legalized gambling is anything but good public policy. ✦



Did You Know?

America’s immigration shift isn’t just a national statistic—Illinois’ demographics are rapidly changing too.

- In **Illinois**, the share of foreign-born residents has grown to **15.4% (=1.96 million)—higher than the national average of 13.8%.**
- In **Chicago**, **22% of residents**—about **597,000 people**—were born outside the U.S., with the largest groups coming from Mexico, China, India, the Philippines, and Poland.
- In New York City, nearly 1 in 3 residents is foreign-born—about 5.8 million people (29%).
- In Los Angeles, 39.7% of the population is foreign-born. The broader Los Angeles metro area has 4.4 million immigrants.
- In the city of Houston, 28.5% of the population is foreign born.

Several major Illinois cities have high percentages of foreign-born residents:

- **Aurora — 25.6%**
- **Naperville — 22.6%**
- **Elgin — 26.3%**
- **Joliet — 15.2%**

Another interesting tidbit: the state of California has the highest percentage of foreign-born residents: 27.7%

These figures—sourced from the U.S. Census Bureau—show that immigration continues to reshape our communities in profound ways. While IFI supports robust legal immigration, the years of open borders have overwhelmed our cities and social welfare safety net, hospitals and education systems. Too many unvetted immigrants are criminals, predators, gang members or even radical jihadists.

A growing number have secured commercial driver’s licenses and are involved in serious highway accidents — incidents that include the deaths of other drivers. Our state, like California, is issuing standard driver’s licenses to illegal immigrants—and under Governor J.B. Pritzker, the push to normalize lawlessness only accelerates. Instead of prioritizing public safety, state leaders are bending over backward to accommodate those who have broken immigration laws, all the while demonizing those who enforce them. ✦

Veto Session Update

We are sad to report that **physician-assisted suicide (SB 1950)** passed the Illinois House in late May and then, as our families slept, the Illinois Senate quietly passed it with the bare minimum vote at 3AM on October 31st.

For years, a broad coalition of organizations and concerned Illinoisans has worked tirelessly to block this legislation. That effort must now shift to the Governor. This legislation puts the most vulnerable among us—the elderly, the disabled, and those struggling with depression—at grave risk.

Illinois is now poised to become the 12th jurisdiction—and the first Midwestern state—to normalize suicide. And make no mistake, the message this sends to our loved ones and neighbors is that suicide is a legitimate “medical option” when life feels too hard to bear.

Our attention now turns to **Governor Pritzker**. We must pray—then call and email his office—and pray again that he will veto this dangerous bill. Every phone call, every email, every prayer matters in defending a culture of life in our state.

This moment is also a sobering reminder: our work is far from finished.



Lawmakers do not have the final word—we do, in our homes, churches, and communities.

It is incumbent on all of us—fathers and mothers, grandparents and church leaders—to teach the next generation the sanctity of human life.

We must be intentional and vigilant, so our children are not pulled in by the deadly lies our culture is trying to sell them.

As for IFI, we will continue to stand for those whose voices are dismissed or silenced. We will continue to point to the Author of Life, who alone gives us dignity, purpose, and worth. ✦

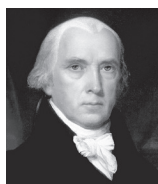
- Eliminates rate caps

- In a **democracy**, rights are whatever the ruling majority decides they are at any given moment.

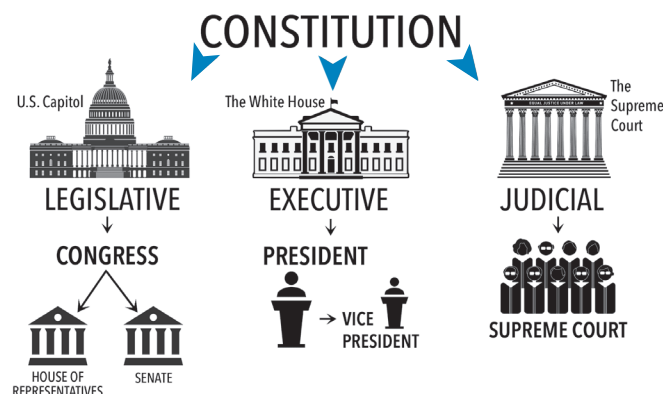


James Madison warned of this danger:

For decades, he shared the benefits of his wisdom, his education, his faith and his unswerving commitment to principle in aiding parents who needed that wisdom and needed to build their own confidence in parenting children prepared to take their place responsibly in leadership, stewardship and citizenship.

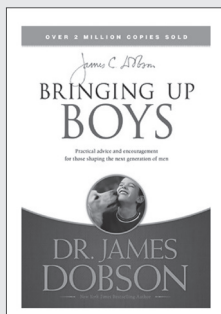
Grateful for Dr. Dobson

The Value of Religion

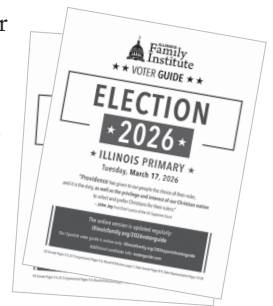


A recent Pew Research Center poll shows a significant shift in how Americans view the role of faith in public life. After hitting a two-decade low in 2024 — when only 18% of adults said religion was gaining influence in America — that number has now surged to 31%, the highest level in 15 years. The new findings, released in late October, reflect a 13-point jump in just one year, signaling renewed recognition of religion's importance in our nation. ✦

Charlie Kirk's Legacy *Written by David E. Smith*

The assassination of Charlie Kirk at Utah Valley University in September has had a profound impact on many Christians in the United States and even around the world.

The IFI staff and board of directors, my wife and children continue to pray for his wife Erika, their two small children and for the staff of Turning Point USA and TPUSA Faith. May God help them deal courageously with the fallout from this horrible situation.

The assassination clearly highlights the depths of human wickedness. Jeremiah 17:9 reminds us: “The heart is deceitful above all things, and desperately wicked.”

That sobering truth is on full display in the cold-blooded murder of Charlie, whose only “crime” was speaking the truth and upholding the Gospel.

Yet we cling to the Apostle Paul’s assurance that believers “do not grieve as others who have no hope” (1 Thessalonians 4:13). Charlie’s life and testimony remind us that death does not have the final word for those in Christ.

A Strong Advocate of Truth

Charlie was a courageous defender of truth. His breadth of knowledge on a wide range of issues was thoroughly impressive. But even more than that, his life reflected a love for God, family, and our nation—values he shared passionately from the heart and inspired millions.

I first met Charlie in 2010 at a Palatine Tea Party event. Though still in high school, he was the evening’s opening speaker—and he spoke with authority, armed with facts and statistics. I followed him as the second speaker and remember

thinking how extraordinary it was that someone so young could hold a room with such confidence and clarity. His poise and insight left a lasting impression.

Raised by two loving parents in the Chicago suburbs, Charlie attended Wheeling High School. Few could have predicted that he would rise to become an international conservative spokesman, media personality, and trusted ally of President Trump and his family.

We take great comfort knowing that Charlie’s faith was genuine. He stood firm in Christ, unwavering in his conviction that mankind’s only hope is found in the only Son of God, Jesus. Today Charlie lives with the Lord he served so boldly.

Going Forward

This assassination is yet another reminder that we are engaged in a war—not of flesh and blood, but a spiritual battle that manifests in chaos, death, and destruction.

In the Olivet Discourse, Jesus warned that in the last days, “the love of many will grow cold” because of the increase of lawlessness and wickedness (Matthew 24). The “love” He described is *agape*—the selfless, sacrificial love that characterizes true Christian faith. That love withers when hearts grow hardened by sin and the influence of worldly values.

The Apostle Paul likewise warned that “in the last days perilous times will come, for men will be lovers of themselves...” (2 Timothy 3:1–3). We are seeing that reality unfold in our time.

How, then, should we respond? We must pray fervently, proclaim the truth boldly, and love steadfastly—even as we



remember that many remain captives of Satan’s lies. Our calling is clear. We must continue to work:

“in humility correcting those who are in opposition, if God perhaps will grant them repentance, so that they may know the truth, and that they may come to their senses and escape the snare of the devil, having been taken captive by him to do his will” (2 Timothy 2:24–26).

To honor Charlie Kirk’s legacy, we must stand firm in the faith, put on the full armor of God (Ephesians 6:11), and overcome evil with good (Romans 12:21). That is how the church advances—not by fear, but by faith; not by hatred, but by love; not by retreat, but by courage, rooted in Christ.

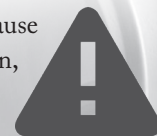
Let us pray without ceasing, speak truth without fear, and love our neighbors without wavering. In a world darkened by lies and violence, we must shine the light of Christ with courage and conviction—for the glory of our good God. 70% of Voters Reject Biden’s Risky Abortion Pill Policy

› Pray that God will open the eyes of policymakers and candidates for office to the sanctity of life. Pray that they will become defenders of innocent human life and not enablers of sexual immorality and death.

› Please specifically pray for former House Speaker Michael Madigan who is now serving time in a federal prison for corruption. Pray that he repents and seeks God.

› Pray for local political leaders to come to the knowledge that Jesus Christ is Lord and Savior. And if they do know the Lord that their relationship with Him would grow and prosper.

› Pray that local officials would seek Godly wisdom and that laws would NOT be passed that go against God’s Word. Pray that God would surround public servants with people that know the Lord and would be a mouthpiece for Him.

› Pray against the efforts to pass legislation to legalize prostitution and regulate homeschooling in Illinois.
